Vendor Instructions

- Concession set up in the "Race Village" is between 9:00am and 1:00pm on Sunday, November 2nd;
Concessionaire shall pay the amount selected for the booth to Super Boat Int'l Prod, 1323 20th Terrace, Key West, FL 33040 as concession fee for the right to offer its product at the location assigned at check-in;
Concessionaire has the right to establish and operate one booth daily and one satellite booth on race days on the outer mole (location is designated by Super Boat Int'l Productions) at the Truman Annex – Southard Street entrance between 8:00am and 6:00pm;
Super Boat Int'l Productions is not responsible for lost or stolen items;
Super Boat Int'l Productions does not guarantee sales and no refunds will be given to concessionaire due to performance of customers;
Concessionaires are responsible for bagging and placing trash in appropriate areas;
Concessionaires must supply their own tent, prep equipment, work tables including sanitary supplies, chairs and fire extinguisher. If using a pop-up tent (10 X 10) it must be reduced to the smallest size (secured suitable to withstand 20 MPH winds) every night or you can rent one through Super Boat Int'l Prod that can stay up. If renting a tent through Super Boat Int'l Prod, it must be rented prior to October 16th;
Concessionaire is responsible for complying with all of the laws concerning its intended operations. Concessionaire will provide Super Boat Int'l Productions, upon request, with its State of Florida sales tax registration number and agrees to collect and pay applicable sales tax in accordance with the laws of the State of Florida. Concessionaire holding licenses for food vending out of the State of Florida must pay a temporary food vending fee to the State Health Inspector at the rate they specify upon request from the inspector;
A parking pass will be given to concessionaire upon check-in and must be displayed on the driver's side of the windshield and park in the designated area at all times;
Concessionaires agrees to locate their booth at the particular location designated by Super Boat Int'l Prod;
No merchandise displaying the wording "Key West World Championship" will be allowed unless approved by Super Boat Int'l Productions;
This is a NON-EXCLUSIVE agreement;

Insurance

- Concessionaire shall indemnify and hold Super Boat Int'l Prod, their respective officers, directors, agents and employees harmless from and against all claims, liabilities, damages, costs and expenses including reasonable attorneys' fees arising out of or resulting from any action or activities by Concessionaire relative to the conduct of Concessionaire's business or incurred by reason of the violation by Concessionaire of any of the terms and conditions of this Agreement;
Concessionaire is required to carry their own certificate of liability insurance and name Super Boat International Productions, Inc. as additional insured this will need to be issued 10 days prior to the event;

Power

Power will not be available. All concessionaires requiring power must bring their own generator;
